APPROVAL OF MINUTES OF NOVEMBER 8TH RECESSED REGULAR MEETING, DECEMBER 7TH RE-CONVENED MEETING AND JANUARY 18, 2000 MEETING - motion to approve minutes by Commissioner Phebus and seconded by Commissioner Buckley. Voice vote. Aye's carried.

Capital projects Committee Report - Jimmy Westbrook, Chairman

Commissioner Phebus Vice Chairman gave the report in the absence of Commission Westbrook, stated that they had met in regards to the renovation of the Courthouse and authorize expenditure.

Motion to amend by Commissioner Phebus for reconstruction of wording in Resolution and seconded by Stewart. Voice vote. Aye's carried. Upon roll call vote by the County Clerk, eighteen for and two absent. County Executive, Gifford requested that this be a part of the minutes.

County Executive, Gifford requested that the County Commissioners appropriate \$20,000.00 for the telephone system for the Courthouse renovation. That request was put into a motion by Commissioner Castleman and seconded by Commissioner Broussard. Upon roll call vote by the County Clerk, eighteen for and two absent. Motion carried.

County Executive, Gifford asked that the May 15, 2000 meeting be reset for third Monday night in June, which would be June 19. Motion to reset meeting to June 19, 2000 by Commissioner Westbrook and seconded by Commissioner Broussard. After

discussion motion to amend meeting to be reset for June 12, 2000 by Commissioner Farmer and seconded by Commissioner Owen. Voice vote. Aye's carried.

On Resolution No 2000-44, County Executive , Gifford requested that the Finance Office amend the Resolution to reflect the transfers and also will go to the Finance, Ways and Means. Commissioner Phebus stated the transfers are from line item 58500-316 to 99110-707.

County Executive, Gifford stated that money had been appropriated for a grant for the Weakley County Highway Department, No 820. Motion made by Commissioner Broussard and seconded by Commissioner Rook. Upon roll call vote by the County Clerk, eighteen for and two absent. Motion carried.

Commissioner Stewart thanked the Capital Project Committee for the good work on the renovation of the Courthouse.

Commissioner Parham thanked the Commissioners for all working together.

Trustee's Relief of Penalty and Interest

Larry Kelly asked for penalty and interest to be deleted on his property taxes that were not paid. He said it was the error of the Weakley County Trustee. County Attorney was not sure if it could be done. Motion to wavier penalty and not interest by Commissioner McAlpin and seconded by Commissioner Overton. Motion to amend by Commissioner Phebus to pay taxes, interest and penalty, to stop assessment of interest and penalty and if they can give any part of interest and penalty, they would decide on that issue at the next meeting and issue a refund check. Commissioner Westbrook suggested that Mr. Kelly paid under protest. Seconded by Commissioner Broussard. Upon roll call vote by the County Clerk, Seventeen for, one no and two absent. Motion carried.

Original motion sixteen for, one no, one passed and two absent. Motion carried.
