WEAKLEY COUNTY COMMISSION MEETING: July 27, 1998 7 P. M. County Executive, Ron Gifford called the meeting to order.

Capital Project Committee James Westbrook, Chairman

Commissioner Westbrook, stated if the budget is approved tonight as presented, we are going to recommend the undertaking of first revocation of the County Court House. Commissioner Westbrook, stated there was not to be a property tax increase or any other tax increase.

Committee on Committee James Westbrook, Chairman

Commissioner Westbrook, stated that the committee met and made recommendations for committee appointment and also for soon to be vacancies for the Veteran Affairs and Emergency Management Civil Defense office. Our recommendation of the committee in the Veteran Affairs that Bill McClain be appointed as interim basi's from August 1, 1998 to September 22, 1998. Also to serve on a committee of Veterans and chaired by Commissioner Seldon Parham, also on committee Mac Buckley, Bill McClain, Larry Tackett and Odie Legens representing the Veterans in the County to solicit application and make recommendations for a meeting on September 1, 1998, who should be appointed to the Veterans Service office. Committee endorsed recommendation from the Public Safety committee to replace the Civil Defense under the direction of David McAlpin to become a part time County employee for that purpose.

Financial Management Committee Ronnie Bates, Chairman

Commissioner Tidwell filled in for Commissioner Bates stated one of the things was the recommendation from the Finance Director that a \$5000.00 limit on bids from the school department based on the recommendations of Superintendent of School and the Finance Director with approval of Committee raising the limit for school purchasing up to \$10,000.00 so they would not have to

take seal bids. Recommendations on the Court House can from the Capital Project Committee that the firms of TLF & HCS be retained to do the managing constructing of the revocation of the Court House. This is also approved by the committees based on the recommendations by the Capital Projects. Another recommendation came to us by the Capital Projects to authorize the sale of the property around the Nursing Home. There is a Resolution written for this. Superintend Barber has received a letter from the Community Center, Old Salem Church that they no longer needed the Community Center, and the County school property, that they are going to turn it back in and we voted to put that in the sale with the approval of the School Board when they approve the sale. Recommendation and motion made that all County employees be paid twice a month, on the 15th and 30th, motion and seconded by the Committee, for all personnel with the exception of the teachers and substitute teachers, elected officials and appointed officials, will be paid on the 15th and 30th of the month. Will be effective January 1, 1999. First payroll will be two weeks later.

Finance, Ways and Means Committee Dick Phebus, Chairman

Commissioner Phebus, ask to remove his remarks until later.

Health, Education and Welfare Committee John Salmon, Chairman

Commissioner Salmon, stated they met and approve the Resolutions that were have tonight.

Legislative Committee Jack Vincent, Chairman

Commissioner Vincent did not give a report.

Personnel Committee John Salmon, Chairman

Commissioner Salmon stated that they had met and discussed the health programs for the employees for the County.

Public Safety Committee John Bucy, Chairman

Commissioner Bucy, stated that their are several items in form of a Resolution that will come under new business. Resolution 1999-04 passed our committee. Under new appointment, we recommend David McAplin to be hire by Weakley County for Civil Defense director with a salary of \$10,000.00. This recommendation came from the FG11 Broad and been endorsed by the Weakley County Fire Chief This motion will come at the appropriate time tonight. Also, recommended that the part time secretary would remain in her office and with the Veterans program. Hear a report by the Weakley County Ambulance service concerning the current contract which expired in June. The recommend of the Public Safety Committee is to renew up to a period of four years. This will come as a motion under new business. Commissioner Bucy, stated that they had heard the recommendation from several people, that \$10,000.00 be added to the budget to provide shelter for the donated ambulance to be housed in the Palmersville fire station. This is a one time request and will be discussed tonight and we recommend this without question.

Public Works Committee George Broussard, Chairman

Commissioner Broussard, stated that the Committee had met and would answer any questions.

Nursing Home Report Vernon Dunn, Chairman

Commissioner Dunn, reported that the Nursing Home was doing well and that everyone had a report.

Finance, Ways and Means Chairman, Phebus, stated that they had met a number of times on budget items and Resolutions 1-2 & 3 and also several other Resolutions that are on the agenda.

Commissioner Phebus, stated that the \$10,000.00 for the Ambulance, came to us late tonight and it is not in the budget, and he had talked to Commissioner Bucy and other members, and he had no objection to it and there would be an amendment to the \$10,000.00 in the budget. Commissioner Phebus thanked the people who worked to get the budget together. He thanked Commissioner Bates for all his loyal support that he gave to being County Commissioner and all the hard work. Thanked Glenda Laney for all she did in helping with the budget and the finance office. The Resolutions on the agenda tonight and at the proper time I will made motion to adopt.

County Executive, Gifford reported on assessment summary from Assessors office.
