"BT TT FURTHER RESOLVED: That the Quarterly Court of the County of Weakley, State of Tennessee elects to assume the liability for tis pro-rate share of administrative costs as stipulated by Section 8-3934 (4), T.C.A. and the pro-rate share of the cost-of-living contribution as granted by the Tennessee State Legislature.

Effective date of Participation shall be October 1, 1977. Beginning Employer Contribution Rate of: Ganeral Fund 6.26%, Bond of Education 15.26%, Highway Department 5.12%, Nursing Home 7.22% on the current and initial lump sum accrued liability of:
