

RESOLUTION NO. 1995-50 AMENDED  
 RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY  
 GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1995

WHEREAS, Weakley County has incurred certain expenses since the budget for FY 1994-95 was adopted including earthquake insurance, extra commission meetings and committee meetings, extra autopsies, service trips and burials; and longevity pay erroneously omitted in certain line items; and

WHEREAS, these expenses having occurred require an adjustment in the 1994-95FY General Fund Budget.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee, assembled in regular session on this 15th day of May, 1995, that:


