

RESOLUTION NO. 1997-24

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN  
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1997.

WHEREAS, A volunteer fire department has been formed by the people of the community of Latham and Dukedom; and

WHEREAS, the Latham/Dukedom Volunteer Fire Department has applied and received an approved charter from the Tennessee Secretary of State; and

WHEREAS, said fire department has purchased a truck, equipment and has participated in training exercises; and

WHEREAS, said fire department will provide much needed rural fire protection to a portion of the county; and

WHEREAS, said fire department has a coverage area established by the Weakley County Fire Chiefs Association; and

WHEREAS, Latham /Dukedom Volunteer Fire Department qualifies for the county supplement of \$3,500.00 (three thousand five hundred dollars).

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 25th day of November, 1996 in Dresden, Tennessee that:


SECTION 2. BE IT FURTHER RESOLVED, that this resolution effects the 1996-97 fiscal year and shall be fiscally continuous thereafter.


