RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN DEBT SERVICE FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.

- WHEREAS, the Weakley County Debt Service Fund budget 1997-98FY is in need of a budget amendment for final payment of a school heating and air conditioning note at Weakley County Bank; and
- WHEREAS, due to the high interest rate of the 6.3% note at Weakley County Bank that would have been paid off in the fiscal year of 2003-2004. This will save the County \$35,959.11 that would have paid on interest for those years; and
- WHEREAS, the Weakley County General Purpose School Fund will reimburse Debt Service Fund for the total payment amount.
