A RESOLUTION TO MAINTAIN A COMMITTEE ON RULES, PROCEDURES AND COMMITTEES OF THE WEAKLEY COUNTY BOARD OF COMMISSIONERS

- WHEREAS, The County Board of Commissioners has such a committee in place, and the need may arise to amend said rules and with the need to appoint committees of the Weakley County Board of Commissioners; and
- WHEREAS, There will be new County Commissioners elected in the August 6, 1998, General Election; and
- WHEREAS, these new officials, as well as the incumbent officials and the general public, need to be knowledgeable of the rules, procedures and committees of the county legislative body.
- NOW, THEREFORE BE IT RESOLVED by the county legislative body of Weakley County meeting in regular session on this the 27th day of July, 1998, in Dresden, Tennessee, that:
- **SECTION 1.** Ten (10) County Commissioners be appointed to serve on a committee to study the rules, procedures and committee structure of the county legislative body, to make recommendations for committee assignments and to make nominations to fill offices as required by law to be filled by the County Commission.

- SECTION 3. In districts 2 and 7, if Commissioner Simmons and Commissioner Wright do not win, the Commissioner receiving the highest number of votes in each respective district in the August General Election be appointed to represent those districts on the committee.
- SECTION 4. The first meeting of the committee will be at 10:00 A.M. (CDT) in the County Courthouse on Tuesday, September 1, 1998. The County Executive and County Clerk are directed to advise the news media and all interested parties of the meeting in full compliance with the state open-meetings law.
- SECTION 5. The committee shall report their recommendations to the county legislative body at the first meeting, whether regular or called, held on or after September 1, 1998. The committee report shall be the first item of business considered at such meeting and in case of a called meeting the committee report shall be included in the call.
