

RESOLUTION NO. 1999-33

RESOLUTION ACCEPTING THE DONATION OF A BUILDING TO BE USED BY THE WEAKLEY COUNTY BOARD OF EDUCATION FOR ADMINISTRATIVE OFFICES AND OTHER COUNTY PURPOSES

WHEREAS, money has been appropriated to renovate, refurbish, and repair the Weakley County Courthouse including upgrading the heating, cooling, and ventilation system; and

WHEREAS, there is a need for storage space for county records and meeting/conference space; and

WHEREAS, there is a serious shortage of office space in the Courthouse particularly in the areas used by the Clerks of Court and for the Administration of Justice; and

WHEREAS, no viable solution to the problem has been suggested other than moving some offices or departments to other sites; and

WHEREAS, no such sites outside the courthouse have been identified that meet all such needs without great expense to the County; and

WHEREAS, an entity, which wishes to remain anonymous at this time, has tentatively offered to donate a suitable building to Weakley County to be used as administrative offices for the Weakley County Board of Education and for other county functions.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of November, 1998 in Dresden, Tennessee that Weakley County accept this generous offer on behalf of the Weakley County Board of Education.

BE IT FURTHER RESOLVED, that the Board of Education be authorized to spend an amount not to exceed \$50,000.00 to make whatever alterations needed to prepare the building for office use.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
