

RESOLUTION NO. 1999-35

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL PURPOSE SCHOOL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 1999.**

WHEREAS, certain events have occurred requiring adjustments in the 1998-99 General Purpose School Fund Budget. An additional \$803.00 was awarded extending total budget to \$25,000.00 \$1,945.00 was added to line item 71600.116 – teachers for additional summer instruction time. Appropriate funds were dispersed in the employee benefits line items. A travel line item had to be added to cover teacher expenses to state required workshops. Deductions were made in instructional and office supplies to compensate for needed funds in the previous line items; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 19th day of January, 1999 in Dresden, Tennessee that:
