**RESOLUTION AUTHORIZING BUDGET AMENDMENTS
TO THE WEAKLEY COUNTY, TN GENERAL FUND
FOR THE FISCAL YEAR ENDING JUNE 30, 1999.**

WHEREAS, the Weakley County Emergency Management Program must comply with all federal and state regulations; and




