## Resolution No. 2000-08

Resolution Authorizing Budget Amendments To The General Purpose School Fund For The Fiscal Year Ending June 30, 2000

WHEREAS, certain events have occurred requiring adjustments in the 1999-00 General Purpose Fund Budget (ABE) where monies had to be placed in line item 189 to cover hiring additional custodial assistance to strip and wax floors at two times per year.

WHEREAS, excess matching funds for the Safe School Act Grant for 1998-99 budget went to fund balance, budgeting is necessary;

WHEREAS, certain adjustments are needed in the Safe and Drug Free Program;

WHEREAS, funds are needed for a phone system;

WHEREAS, monies appropriated through Education Edge Partnership to sponsor the West Tennessee Regional Education Edge Conference;

WHEREAS, state requirement of staff inservice training has increased for 1999-2000 and therefore, has become necessary to add the 73300-457 line;

WHEREAS, projection for supplies and materials will exceed approved amount;
