

RESOLUTION NO. 2000-11
RESOLUTION AUTHORIZING THE CREATION OF A
NEW LINE ITEM FOR THE LITTER GRANT FUND

WHEREAS, the Weakley County Litter Program has received notification that the State of Tennessee has approved the 1999-2000 Litter Grant Contract in the amount of \$44,701; and

WHEREAS, the 1999-2000 budget reflects the Litter Grant to be \$39,340, therefore an increase in the revenue line #46430 is necessary; and

WHEREAS, it has been recommended by the Tennessee State Division of County Audit that a new line item be established for educational awareness; and

WHEREAS, the County Uniform Chart of Accounts states that #532 Litter Enforcement Awards be utilized for the expenses in the prevention of litter; and

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley, County, Tennessee assembled in regular session on this the 20th day of September, 1999 in Dresden, Tennessee that this resolution is hereby approved.

SECTION 1. The Weakley County Highway Fund is hereby amended as follows:
