RESOLUTION 1972-14

PRIVATE CHAPTER NO. 379, HOUSE BILL NO. 2521 by Bates, McWherter Substituted for: Senate Bill No. 2314 by Hamilton

AN ACT to amend Chapter 640 of the Private Acts of 1949, the same being the Road Law of Weakley County, as amended by Chapter 546 of the Private Acts of 1951, Chapter 14, of the Private Acts of 1965, Chapter 121 of the Private Acts of 1967, and Chapter 444 of the Private Acts of 1968.

BΕ IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE O.H. TENNESSEE:

SECTION 1. Chapter 640 of the Private Acts of 1949, the same being the Road Law of Weakley County, as amended by Chapter 546 of the Private Acts of 1951, Chapter 14 of the Private Acts of 1965, Chapter 121 of the Private Acts of 1967, and Chapter 444 of the Private Acts of 1968 is amended by deleting from Section 1, paragraph 2 in its entirety, and substituting in lieu thereof, the following:

(continued)

All counties to which this Act applies shall be divided into seven (7) road districts or zones, as follows:

ZONE 1: Civil District 3 and the Western half of Civil District 2 divided by the Illinois Central Railroad Company's railroad running through the city of Martin, Tennessee.

ZONE II. The Eastern Half of Civil District Central Railroad Company's railroad running Tennessee, and Civil Districts 17 and 20. through the City of Martin,

ZONE III. Civil Districts 13, 1, 4, 25, 5, 24,

ZONE IV: Civil Districts 10, 23, 11, 12, 15

ZONE ۷: Civil Districts 22, 9, and 16.

ZONE VI: Civil Districts 14, 18, 19, and 8,

ZONE VII: Civil District 7.

Such districts hereinabove referred to are those existing at the time of the effective date of this Act.

SECTION 2. This Act shall have no effect unless it is approved by a two-thirds (2/3) vote of the Quarterly County Court of any county to which it may apply on or before August 1, 1972. Its approval or non-approval shall be proclaimed by the presiding officer of any Quarterly County Court to which it may apply and certified by him to the Secretary of State.

SECTION 3. For the purpose of approving or rejecting the provisions of this ACT, as provided in Section22, it shall be effective on becoming a law, the public welfare requiring it. For all other purposes it shall become effective upon being approved as provided in Section 2.
