

RESOLUTION NO. 1981-29

A RESOLUTION MAKING APPROPRIATIONS TO NON-PROFIT CHARITABLE ORGANIZATIONS OF WEAKLEY COUNTY, TENNESSEE FOR THE FISCAL YEAR BEGINNING JULY 1, 1981 AND ENDING JUNE 30, 1982.

WHEREAS, Section 5-932, Tennessee Code Annotated, authorizes the County Legislative Body to make appropriations to non-profit charitable organizations; and,

WHEREAS, the Weakley County Legislative Body recognizes the various non-profit charitable organizations located in Weakley County have great need of funds to carry on their non-profit charitable work,

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County, on this 20th day of July, 1981,

SECTION 1. That \$1,600.00 be appropriated to the Weakley County Rescue Squad to promote civil defense operations in the county.

SECTION 2. That \$2,150.00 be appropriated to Easter Seal Society for rehabilitation for the handicapped in Weakley County.

SECTION 3. That \$750.00 be appropriated to West Tennessee Speech and Hearing for services to the citizens of Weakley County.

SECTION 4. That \$642.00 be appropriated to Jackson Area Council on Alcoholism to promote education and rehabilitation in alcohol and drug abuse.

SECTION 5. That \$10,600.00 be appropriated to Obion-Forked Deer Basin Authority to be used in solving surface water problems in the county.

SECTION 6. That \$10,000.00 be appropriated to County Chamber of Commerce to promote the economic welfare of Weakley County.

SECTION 7. That \$500.00 be appropriated to Tourism to promote additional revenue for the county.

SECTION 8. That \$12,840.00 be appropriated to the Regional Mental Health Center for a wide range of services to the citizens of Weakley County.

BE IT FURTHER RESOLVED, that all appropriations enumerated in

Sections 1 through 8 above are made subject to the following conditions:
