Resolution Authorizing Budget Amendments To The Weakley County, TN General Fund For The Fiscal Year Ending June 30, 2018

WHEREAS, new monies must be budgeted for the purchase of a new voting system for the Weakley County Election Commission; and,

WHEREAS, \$10,000 per voting precinct has been made available through the Help Americans Vote Again (HAVA) Act, bringing Weakley County's portion total to \$110,000; and

WHEREAS, the total expense to purchase a new voting system is \$159,790; and,

WHEREAS, the additional funds to purchase said machines must be expensed from the previously appropriated account in Fund 171, General Fund Capital Projects.

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of November, 2017 that:
