**The purpose of the enclosed is to provide Notice of Employees of Coverage Options under the Fair Labor Standards Act §18B and Updated Model Election Notice under the Consolidated Omnibus Budget Reconciliation Act of 1985.**

**The Affordable Care Act require employers to provide a notice of coverage option to each employee, regardless of plan enrollment status or part-time status.**

# New Health Insurance Marketplace Coverage Options and Your Health Coverage

## **PART A: General Information**

There is an additional option to buying health insurance: the Health Insurance Marketplace. To assist you as you evaluate options for you and your family, this notice provides some basic information about the new Marketplace and employment based health coverage offered by your employer.

### **What is the Health Insurance Marketplace?**

The Marketplace is designed to help you find health insurance that meets your needs and fits your budget. The Marketplace offers "one-stop shopping" to find and compare private health insurance options. You may also be eligible for a new kind of tax credit that lowers your monthly premium right away. Open enrollment for health insurance coverage through the Marketplace begins in October 2015 for coverage starting as early as January 1, 2016.

### **Can I Save Money on my Health Insurance Premiums in the Marketplace?**

You may qualify to save money and lower your monthly premium, but only if your employer does not offer coverage, or offers coverage that doesn't meet certain standards. The savings on your premium that you're eligible for depends on your household income.

### **Does Employer Health Coverage Affect Eligibility for Premium Savings through the Marketplace?**

Yes. If you have an offer of health coverage from your employer that meets certain standards, you will not be eligible for a tax credit through the Marketplace and may wish to enroll in your employer's health plan. However, you may be eligible for a tax credit that lowers your monthly premium, or a reduction in certain cost-sharing if your employer does not offer coverage to you at all or does not offer coverage that meets certain standards. If the cost of a plan from your employer that would cover you (and not any other members of your family) is more than 9.5% of your household income for the year, or if the coverage your employer provides does not meet the "minimum value" standard set by the Affordable Care Act, you may be eligible for a tax credit.<sup>1</sup>

**Note:** If you purchase a health plan through the Marketplace instead of accepting health coverage offered by your employer, then you may lose the employer contribution (if any) to the employer-offered coverage. Also, this employer contribution -as well as your employee contribution to employer-offered coverage- is often excluded from income for Federal and State income tax purposes. Your payments for coverage through the Marketplace are made on an after-tax basis.

Here is some basic information about health coverage offered by this employer:

- As your employer, we offer a health plan to:
  - All employees.
  - Some employees. Eligible employees are:
    - Any employee scheduled to work at least 30 hours per week in a non-seasonal, non-temporary position
    - Any member of the chief legislative body of the county or municipal government (defined as only those elected officials who have the authority to pass local legislation)
    - Utility board members appointed or elected pursuant to TCA 7-82-307, but only during their term of service
    - County officials as defined in TCA 8-34-109(9) (A) and (B), regardless of whether the agency participates in the plan, pursuant to TCA 8-27-207(i)
    - All other individuals cited in state statute or approved as an exception by the Local Government Insurance Committee
    - Any person who is otherwise defined as an eligible employee under the Patient Protection and Affordable Care Act (PPACA), provided that the employer has decided to voluntarily offer coverage prior to the required implementation
- With respect to dependents:
  - We do offer coverage. Eligible dependents are:
    - Your spouse (legally married)
    - Natural or adopted children
    - Stepchildren
    - Children for whom you are the legal guardian
    - Children for whom the plan has qualified medical child support orders
  - We do not offer coverage.
- If checked, this coverage meets the minimum value standard, and the cost of this coverage to you is intended to be affordable, based on employee wages.

\*\* Even if your employer intends your coverage to be affordable, you may still be eligible for a premium discount through the Marketplace. The Marketplace will use your household income, along with other factors, to determine whether you may be eligible for a premium discount. If, for example, your wages vary from week to week (perhaps you are an hourly employee or you work on a commission basis), if you are newly employed mid-year, or if you have other income losses, you may still qualify for a premium discount.

If you decide to shop for coverage in the Marketplace, [HealthCare.gov](http://HealthCare.gov) will guide you through the process. Here's the employer information you'll enter when you visit [HealthCare.gov](http://HealthCare.gov) to find out if you can get a tax credit to lower your monthly premiums.
