**Resolution Authorizing Budget Amendments To The Weakley County, TN
General Fund For The Fiscal Year Ending June 30, 2019**

WHEREAS, the Weakley County Clerk & Master held a delinquent property tax sale on October 18, 2018; and

WHEREAS, payment of these properties needs to be appropriated in the 2018-2019 fiscal year budget.






