Resolution Authorizing Budget Amendments To The <u>General Purpose School</u> Fund For The Fiscal Year Ending June 30, 2019

WHEREAS, Education Edge reserve monies need to be adjusted; and, 3 Star Grant monies to enhance Advanced Manufacturing; and,

WHEREAS, amendments need to be made in the General Purpose Special Education Program to include additional revenue from the State for reimbursement of high cost expenditures for IDEA students that occurred in the 2017-18 school year.
