**Resolution Authorizing Budget Amendments To The Weakley County, TN
General Fund For The Fiscal Year Ending June 30, 2019**

WHEREAS, the Weakley County General Fund Budget for the FY 2018-19 is in need of realignment in estimated expenditures due to the fact that Weakley County has been awarded a grant from the State of Tennessee for courtroom security. As a requirement of the grant, the county is responsible for 10% of the total project cost. The county's portion will be funded from the courtroom security reserve fund, and proceeds of the grant will be used to bulletproof all of the benches in the court rooms in the Weakley County Courthouse.

NOW, THEREFORE, BE IT RESOLVED by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 14th of January, 2019, that:

SECTION 1: The Weakley County General Fund is hereby amended as follows:






