## AGENDA WEAKLEY COUNTY LEGISLATIVE BODY REGULAR MEETING JANUARY 19, 1988

The County Commission met in regular session on January 19, 1988 and Co. Exec. Kerry S. Killebrew called the meeting to order. Comm. Lewis Garner gave invocation and Sheriff Mike Wilson opened court. CountyClerk Faye Butts called roll with 17 present, 2 absent and 1 absent because of resigning. Approval of minutes of last meeting was made by Comm. James Harold bell and seconded by Comm. Jimmy Brasfield. After a voice vote, motioned carried.

TRUSTEE'S REPORT: Motion to accept the trustees report was made by Comm. Joe White and seconded by Comm. Gene Harris. After a voice vote, motion was approved.

GENERAL FUND REPORT: Motion to accept the General Fund report was made by Comm. Earl Wright and seconded by Comm. Charles Culver. After a voice vote, motion was approved.

HEW REPORT: Comm. Vincent told the comm. that there was another transfer of landfill from Walker to Barker Brothers. In the permit there will be some stipulation. One is a 90 day probation period and second is that there will be a 50 mile radius for waste to be brought in. No out of state waste unless it gets it O.K. from the rest of the commissioners. Also Jerigan has gone out of busifness and the HEW Comm. will met 1-22-88 and they will try to have it all worked out so there will no disrubtion with service for Rural pickup. Included is resignation of County Commissioner Walter T. Benson. He has moved out of his zone. Comm. Sam Sinclair nominates John Bucy as his replacement. Comm. James Harold Bell made the motion to accept Mr. Bucy and Comm. Earl Wright seconded the motion. After a roll call, motion carried.
