Charles Culver.

TRUSTEES REPORT: Motion to accept this report was made by Comm. Van Cleave and seconded by Comm. Charles Culver. After being put to a voice vote, motion carried.

GENERAL FUND REPORT: Motion to accept this report was made by <u>Comm. James</u> <u>H. Bell</u> and seconded by <u>Comm. Gene Harris</u>. After being put to a <u>voite</u> vote, motioned carried.

HIGHWAY DEPT. REPORT: Motion to accep this report was made by <u>Comm. Charles</u> <u>Culver and seconded by Comm. Earl Wright.</u> After being put to a <u>voice vote</u>, motion carried.

SCHOOL DEPT REPORT: Motion to accept the school dept report was made by Comm. Sam Sinclari and seconded by Comm. Shanklin. After being put to a voice vote, motion carried.

NURSING HOME REPORT. Motion to accept this report was given by <u>COMM. Lewis</u> Garner and seconded by Comm. J. T. Walker. After being put to a <u>voice vote</u>, motion carried.

FINANCIAL MANAGEMENT COMMITTEE REPROT: Comm. Dunn reported to the Commissions that they are hoping for the new computer by September. Motion to accept the report was made by Comm. Joe White and seconded by Comm. David McAlpin. After a voice vote, motion carried.

PROPERTY COMMITTEE REPORT: Comm. McCreight told the court about buying the new buildings and working on other schools in the county. He said the resolution for the capital outlay note was further along in the new business. Motion made to accept this report was made by Comm.James H. Bell and seconded by Comm. Joe white. After a voice vote, motion carried.

COMMITTEE APPOINTED TO MEET WITH ELECTION COMMISSION REGARDING RESTORING VOTING PRECINCTS: Comm. Shanklin and the Committee met in an open meeting with the election commission and the committee comes back with the recommendation for the election commission to restore four (4) voting boxes. 1.
