TO THE MEMBERS OF THE QUARTERLY COURT OF WEAKLEY COUNTY, TENNESSEE

Dear Sir:

You are hereby notified that there will be a called session of the Quarterly Court of Weakley County, Tennessee, at the courthouse in Dresden, Tennessee, on Friday March 7, 1969, at 10:00 A. M. for the purpose of considering the authorization and issuance of Interest Bearing Bond Anticipation Notes in an amount not to exceed \$4,250,000 by Weakley County, Tennessee, and providing for the retirement of said notes which shall be applied exclusively to purchase property for school purposes, to purchase sites for school buildings, to erect or repair school buildings and to furnish and equip school buildings, and to do any and all other purposes by the County Board of Education of Weakley County; and to do any and all other acts necessary and to take such action in connection therewith as the Court may deem necessary, proper, and appropriate. Said notes shall be retired by the \$4,250.00 Bond Issue which has already been approved by the Court.
