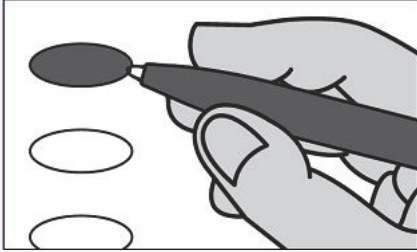

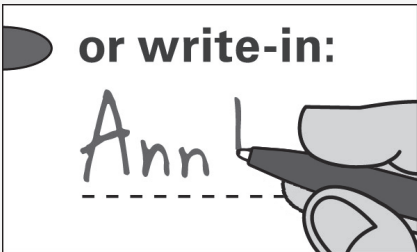
**Making Selections**
