RESOLUTION NO. 1974-23

A RESOLUTION TO APPROPRIATE FROM THE FUNDS OF THE COUNTY GENERAL, GENERAL PURPOSE SCHOOL AND NURSING HOME FUNDS SUCH AMOUNT OR AMOUNTS AS MAY BE REQUIRED TO PAY FOR THE SERVICES OF AN ACTUARY IN DETERMINING THE COST TO SAID FUNDS WITH RESPECT TO THE EMPLOYEES OF WEAKLEY COUNTY PARTICIPATING IN THE TENNESSEE CONSOLIDATED RETIREMENT SYSTEM.

WHEREAS, the Weakley County Quarterly Court is contemplating petitioning the Board of Trustees of the Tennessee Consolidated Retirement System to approve coverage for its employees in the Tennessee Consolidated Retirement System as so authorized under Public Chapter No. 814, Section 10, and

WHEREAS, said Weakley County Court desires to consider the cost of such coverage prior to final approval of said coverage, and

WHEREAS, the determination of such cost requires the services of an Actuary who, under State Law, should be compensated for such services from said County General, General Purpose School and Nursing Home funds.

NOW, THEREFORE, BE IT RESOLVED BY THE QUARTERLY COUNTY COURT OF WEAKLEY COUNTY, TENNESSEE

1. There is hereby appropriated from unappropriated surplus of the County General Fund \$200.00; from the unappropriated surplus of the General Purpose School Fund \$500.00 and from the funds of the Nursing Home such amounts required to compensate for the actuarial services of determining the costs of the participation of its employees in the Tennessee Consolidated Retirement System.

2. Upon receipt of such determination the County Judge, Superintendent of Schools and Nursing Home Superintendent are hereby authorized and directed to pay over the amounts appropriated in the First Section hereinabove contained, to the Tennessee Consolidated Retirement System.
