

RESOLUTION TO CONVEY LAND NOW OWNED BY WEAKLEY COUNTY,
TENNESSEE TO THE WEAKLEY COUNTY BOARD OF EDUCATION.

WHEREAS, Weakley County, Tennessee now owns certain property situated in the City of Martin, County of Weakley, State of Tennessee, in the 2nd Civil District and more fully described in Deed Book 115, Page 37 in the Register's Office, Weakley County, Tennessee it being the same property conveyed of Weakley County, Tennessee by deed of John M. Gardner, Jr., et ux; and,

WHEREAS, this property is south and adjacent to property now owned by the Weakley County Board of Education; and,

WHEREAS, this property is for the use and is being used by the Weakley County Board of Education; and,

WHEREAS, it has come to the attention of this Court that the Weakley County Board of Education desires to lease certain properties adjacent to the afore mention property, owned by Weakley County to the City of Martin Tennessee; and,

WHEREAS, the City of Martin, Tennessee has requested the Weakley County Quarterly Court to consider leasing the afore said property, owned by Weakley County, Tennessee to the City of Martin, Tennessee; and,

WHEREAS, the Weakley County Quarterly Court Property Committee after considering all matters concerning this property has determined that it would be in the best interest of all concerned for the Weakley County Quarterly Court to convey said property to the Weakley County Board of Education.
