RESOLUTION NO. 1975-32

RESOLUTION TO ALLOW DEPOSIT OF DRIVERS LICENSE IN LIEU OF BAIL FOR CERTAIN TRAFFIC VIOLATIONS

WHEREAS, the General Assembly of the State of Tennessee has amended the Tennessee Code by passage of Chapter 28, Public Acts of 1975; and, WHEREAS, Chapter 28 will allow the deposit of a chauffeur's or operators license in lieu of bail in certain cases involving traffic violation; and, WHEREAS, Chapter 28 was such a deposit of drivers license in lieu of bail only after approval of such procedure by a resolution of the Quarterly County Court.

NOW THEREFORE BE IT RESOLVED BY the Weakley County Quarterly Court that: SECTION 1. The deposit of chauffeur's or operator's license in accordance with Tennessee Code Annotated Section 59-730 shall be accepted in lieu of bail in traffic violation charges arising in Weakley County. Provided, however, that no license shall be accepted in lieu of bail in any case where the charged violation would requirw a mandatory revocation of license.

This resolution shall take effect on October 13, 1975 and as otherwise provided by law, the general welfare of the County of Weakley requiring it.

Motion made by Clyde Miles that the foregoing resolution be approved, motion seconded by John Harris. Upon being put to a voice vote the motion carried unanimously.
