

RESOLUTION NO. 1976-10:

SEE FILE FOR REVISED MAP OF ROADS IN WEAKLEY COUNTY:

A resolution to identify and to classify the public roads of Weakley County pursuant to provisions of Sections 54-903 and 54-904, Tennessee Code Annotated.

WHEREAS, it has been determined that the Weakley County Quarterly Court has not at any prior date identified and/or classified the public roads of this County as prescribed by the above named statutes, and,

WHEREAS, the Weakley County Highway Commission has drafted a revised map on which all public roads subject to maintenance by the County are identified and classified in keeping with provisions of Section 54-903 and 54-904, Tennessee Code Annotated and,

WHEREAS, the Weakley County Highway Commission has requested this Court to adopt the system recommended and to direct that expenditures for maintenance and construction be confined to the roads so identified.

NOW, THEREFORE BE IT RESOLVED by the Weakley County Quarterly Court in regular session this 12th day of January 1976 that:

1. The revised map appended hereto is hereby declared to be the official draft reflecting four (4) classifications of the public roads of Weakley County to be maintained by the Weakley County Highway Department.

2. Maintenance and construction shall be restricted to roads reflected on the revised map.

3. Pursuant to provisions of Section 54-904, Tennessee Code Annotated all roads are hereby placed in one of the following classifications:

1. Federal Secondary-hard surface with eighty (80) to one hundred (100) ft. right-of-way.

2. Roads with fifty (50) to eighty (80) ft. right-of-way with chert or hard surface.

3. Roads with fifty (50) ft. right-of-way with a twenty (20) foot chert surface.

4. Roads without established right-of-way with a rock travel surface of twenty (20) ft. or less.

4. The classification of each road in the system shall be reflected on the approved map.

5. All subsequent proposals for addition to the herein designated system of roads must meet specifications of one of the above described classifications and be approved by the Weakley County Highway Commission before presentation to this court for consideration.

6. Any all previous action (s) of this court determined be to in conflict with provisions of this resolution are hereby rescinded.
