

RESOLUTION NO. 1977-29

A RESOLUTION TO PROHIBIT THE ELECTED SHERIFF  
FROM RESIDING IN THE LIVING QUARTERS NOW PROVIDED  
AT THE COUNTY JAIL EFFECTIVE SEPTEMBER 1, 1978.

WHEREAS, The elected sheriffs and their families have resided in space provided, at the county jail for many years, and

WHEREAS, LIVING space is not adequate, as now provided, due to one room being utilized as an administrative office and additional space being required for the communication center, and

WHEREAS, The TCA does not require the elected sheriff to reside at the county jail.

NOW, THEREFORE, BE IT RESOLVED BY THE WEAKLEY COUNTY QUARTERLY COURT in regular session, this the 11th day of July, 1977, that:

1. The elected sheriff of Weakley County is prohibited to reside at the county jail beginning Sept. 1, 1978.
2. The Quarterly Court will provide funds in the annual county jail budget to employ a jailer to operate the county jail.

3. The County Court Clerk will have this resolution published in all county newspapers in sufficient time for all candidates for sheriff in the 1978 election to be acquainted with the provisions of this resolution.
