

RESOLUTION NO. 1995-101

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENNESSEE, GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1996.

BEAS, NWTDC is renting space in the county building (old Health Dept. building) in the amount of \$2,000.00 per month beginning on December 1st, 1995; and

BEAS, Prior to the Election Commission occupying the county building (old Health Dept. building), it is in need of some inside renovations such as painting, new counter, carpet, etc.; also needs outside ramp for handicapped; and

BEAS, these expenses having occurred require an adjustment in the 1995-96 Fiscal Year of the Weakley County General Fund budget.
