We are requesting that the current Driver Education budget be amended by transferring money previously reserved to line items 71400-718- Motor Vehicles and 71400-7222- Regular Instructional Equipment.

The reasons for this request:

- 71400-718 DRV- Motor Vehicles- We plan to replace at least two of the current driver education cars. We currently have a 1989 Sunbird and a 1990 Dodge Dynasty that we would like to replace. Our goal is to continue to move up in model year and down in mileage as better cars become available through State Surplus Property. Recent checks at State Surplus Property found that they had 1993 Pontiac Bonneville's with approximately 50,000 miles for roughly \$8,000.00. This type car should meet our needs for the next three or four years.
- 71400-722 DRV- Regular Instructional Equipment- We have computer equipment which was purchased in 1992. As this equipment ages it will need to be replaced. We would like to start that process.

During the past years we have been very conservative with the Driver Education money. Through leasing of vehicles and purchase of vehicles through Surplus property we have been able to build a \$25,890.00 reserve. This amendment will leave \$9,691.74 in reserve.
