

RESOLUTION NO. 1997-71

RESOLUTION AUTHORIZING ROAD NAME CHANGE  
FROM MAC TERRELL ROAD TO J.E. HAZLEWOOD RD.

WHEREAS, Resolution No. 1997-32 provides that a road may be petitioned for name change when petition for such change contains the signatures of eighty percent (80%) of landowners residing on said roads along with a statement of agreement to the proposed change. Only one signature per parcel of land adjoining said road or roads will be recognized as counting toward the number of signatures required. \*Exhibit A attached.

WHEREAS, Mac Terrell Road has been petitioned for a road name change to J. E. Hazlewood Rd. and upon passage will hereafter be called by that name.

NOW, THEREFORE BE IT RESOLVED, that the Weakley County Board of Commissioners, assembled in regular session on this the 23<sup>rd</sup> day of May, hereby changes the above named Mac Terrell Rd. to J.E. Hazlewood Rd.

BE IT FURTHER RESOLVED, that the road is designated on the attached map.

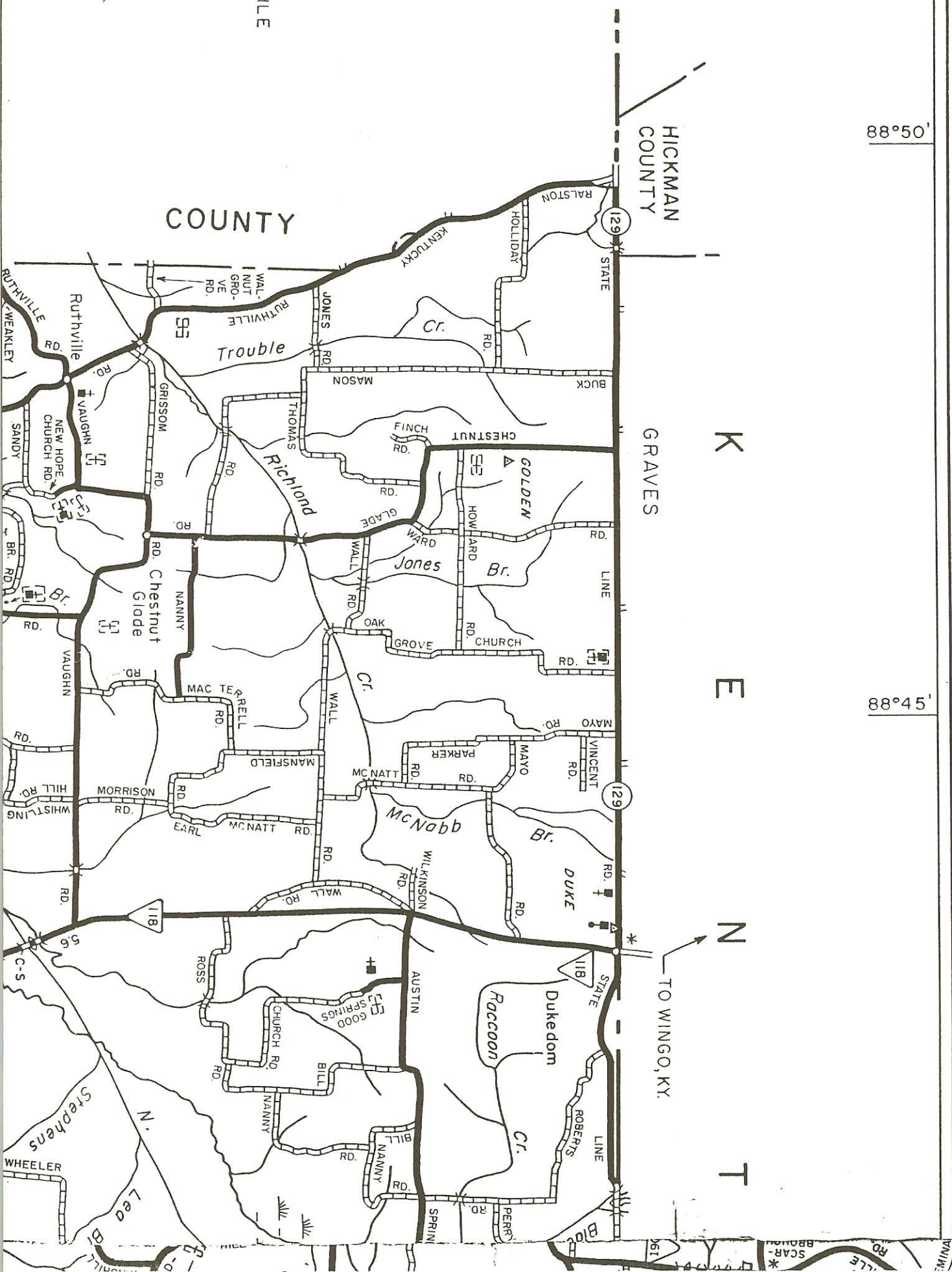
