

RESOLUTION NO. 1998- 5

A RESOLUTION TO AUTHORIZE RETIREMENT CREDIT FOR SICK LEAVE FOR EMPLOYEES OF A POLITICAL SUBDIVISION PARTICIPATING IN THE TENNESSEE CONSOLIDATED RETIREMENT SYSTEM IN ACCORDANCE WITH TITLE 8 SECTION 34 THROUGH 37 OF THE TENNESSEE CODE ANNOTATED

WHEREAS, the Tennessee Code Annotated Section 8-34-604(c), permits a political subdivision to allow their employees, upon retirement, who have any unused accumulated sick leave to be credited with such accrued leave as creditable service, and;

WHEREAS, the sick leave policy is that sick leave will accumulate at a rate of one-half day for the first six months of employment and one day for each month thereafter accumulating to a maximum of ninety (90) days, and;

WHEREAS, all liabilities resulting from this Resolution shall be the responsibility of the political subdivision and not the State of Tennessee.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this, the 28th day of July, 1997 in Dresden, Tennessee hereby authorize retirement credit for unused accumulated sick leave pursuant to Tennessee Code Annotated Section 8-34-604(c).

BE IT FURTHER RESOLVED, that all county officials and department heads shall forward by the tenth day of the month following the accumulation a certified statement of sick leave and annual leave earned, used, and accumulated to the county Director of Finance who shall be responsible for maintaining all leave records in a permanent file.

BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Board of County Commissioners.
