

**RESOLUTION NO. 1998-44**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENNESSEE, HIGHWAY FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.**

**WHEREAS**, this budget amendment is to realign the revenue received from the Highway Department's surplus property sale; and

**WHEREAS**, this amendment will also realign the budget appropriation for the same amount, due to the transfer during the month of December; and

**WHEREAS**, in December there was a need for an emergency repair to a ditching machine for the Highway Department. The money was transferred to repair of equipment from the diesel fuel account and the revenue received will be used to realign money that was transferred.

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of January, 1998 in Dresden, Tennessee that:

**SECTION 1.** The Weakley County, Highway Fund is hereby amended as follows:




