

RESOLUTION NO. 1998-86

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TENN
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1998.**

WHEREAS, the Weakley County General Fund budget 1997-98FY is in need of adjustments in estimated insurance accounts of workers compensation and health insurance; and

WHEREAS, the workers compensation insurance is paid each fiscal year on estimated payroll figures, then an audit is done on the actual payroll accounts for that year. The county is then billed for the difference of the estimated versus the actual payroll; and

WHEREAS, the health insurance has a premium increase effective May 1, 1998 and due to the number of increased participation throughout the fiscal year has caused the need for increases in the health insurance account.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 18th day of May, 1998 in Dresden, Tennessee that:


SECTION 1. The Weakley County, General Fund is hereby amended as follows:


