

RESOLUTION NO. 1999-16

RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND

SECTION 1. The Weakley County, General Fund is hereby amended as follows:


