

RESOLUTION NO. 1999- 34

RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL PURPOSE SCHOOL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 1999.

WHEREAS, the Weakley County Board of Education is in great need of office and storage space; and

WHEREAS, no viable solution to the problem has been suggested other than moving some offices to other sites; and

WHEREAS, no sites have been identified that meet all such needs without great expense to the County; and

WHEREAS, an entity, which wished to remain anonymous at this time, has tentatively offered to donate a suitable building to Weakley County to be used as administrative offices for the Weakley County Board of Education and for other county functions.

WHEREAS, the Board of Education be authorized to spend an amount not to exceed \$50,000 to make whatever alterations to prepare the building for office use.

NOW THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this 23<sup>rd</sup> day of November, 1998 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Purpose School Fund is hereby amended as follows:


