

**RESOLUTION NO. 1999-45**

**RESOLUTION AUTHORIZING BUDGET AMENDMENTS  
TO THE WEAKLEY COUNTY, TN GENERAL FUND  
FOR THE FISCAL YEAR ENDING JUNE 30, 1999.**

**WHEREAS**, the Weakley County Finance Department is need of a copier, the current copier has been in use since 1993 and has made well over 150,000 copies with a drum life of 100,000 copies; and

**WHEREAS**, the State of Tennessee Active Statewide Contract No. 404 provides for rental of copiers to governmental agencies at a considerable lower monthly rate; and

**WHEREAS**, the Financial Management Committee approved for the lease of Minolta copier at a monthly rate to be paid from a rental line item; and

**WHEREAS**, the Finance Department's budget does not currently include a rental line item that is needed for the monthly rental payments; and

**NOW, THEREFORE BE IT RESOLVED**, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 15<sup>th</sup> day of March, 1999 in Dresden, Tennessee that:

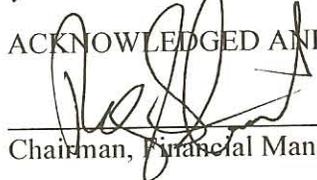
**SECTION 1.** The Weakley County, General Fund is hereby amended as follows:

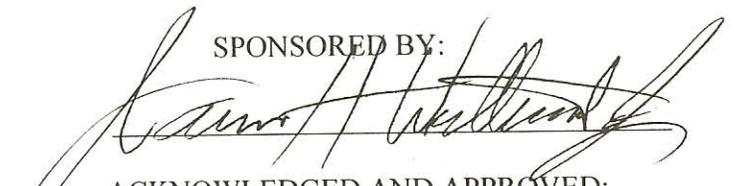
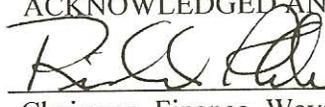

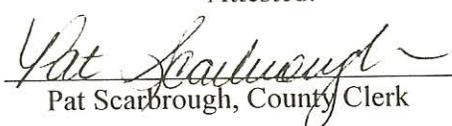
