

RESOLUTION NO. 2000-36

RESOLUTION TO APPOINT MEMBERS OF THE COMMISSION OF THE POOR

WHEREAS, Section 71-5-21. T.C.A. provides for, at the expense of the county, an asylum for the poor of the county, consisting of a parcel of land of such size, and of buildings of such dimensions and construction as may be deemed necessary and proper; and

WHEREAS, the county legislative body may appoint three (3) commissioners to be known as the "Commissioners of the Poor for Weakley County" who may select the site, contract for and superintendent the necessary buildings, upon such plan and under such rules and regulations as the county legislative body may prescribe. The county legislative body shall select the commissioners for a term of one (1) year, another for a term of two (2) years and a third for a term of three (3) years creating staggered terms. The county legislative body shall appoint (1) commissioner for a three (3) year term annually thereafter. Should the legislative body fail to make the appointment in the October session, it may be done in any subsequent session. Said commissioners shall appoint one (1) of their number as chairman.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 20th day of March, 2000 in Dresden, Tennessee this resolution is hereby approved.

SECTION 1. That the following three (3) County Commissioners be appointed "Commissioners of the Poor for Weakley County":


George Broussard	for one (1) year expiring in October 2000
Eric Owen	for two (2) years expiring in October 2001
Richard Phebus	for three (3) years expiring in October 2002

SECTION 2. BE IT FURTHER RESOLVED, that all resolutions of the Board of County Commissioners of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

SECTION 3. BE IT FURTHER RESOLVED, that this resolution take effect from and after its passage, the public welfare require in it. This resolution shall be spread upon the minutes of the Board of County Commissioners.




