

RESOLUTION NO. 2011-41

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE WEAKLEY COUNTY, TN  
GENERAL FUND FOR THE FISCAL YEAR ENDING JUNE 30, 2011.

WHEREAS, the Weakley County Clerk is in need of a new computer server and the funds are available in the Juvenile Court reserved for automation account; and

WHEREAS, the Weakley County Trustee's surety bond was more than projected; and

WHEREAS, the State of Tennessee has awarded the Weakley County Sheriff's Department a \$5,000 Highway Safety grant, with no local match, to purchase vehicle in-car video equipment, DUI checkpoint supplies, and other law enforcement equipment; and

WHEREAS, the Weakley County Office on Aging has received a \$500 Arts Grant and 16-passenger van; line items for these revenues and expenditures need to be budgeted.

NOW, THEREFORE BE IT RESOLVED, by the county legislative body of Weakley County, Tennessee assembled in regular session on this the 23rd day of May, 2011 in Dresden, Tennessee that:

SECTION 1. The Weakley County General Fund is hereby amended as follows:


