RESOLUTION FIXING THE TAX LEVY IN WEAKLEY COUNTY TENNESSEE, FOR THE FISCAL YEAR BEGINNING JULY 1, 1968.

Section 1. BE IT RESOLVED by the Quarterly County Court of Weakley County, Tennessee, assembled in regular session on this the 1 day of July, 1968, that the combined property tax rate fo Weakley County, Tennessee, for the fiscal year beginning July 1, 1968, shall be \$3.65 on each \$100.00 of taxable property within the county, whic is to provide revenue for each of the following funds amd other wise conform to the following levies:

Section 2. BE IT RESOLVED that there is hereby levied by and for the use of Weakley County, Tennessee, a privilege tax upon merchants and other vocations, occupations, and businesses doing business or exercising a taxable privilege in Weakley County, Tennessee, which are declared to be privileges by the General Revenue Act of the State of Tennessee and amendments thereto, in accordance with said Acts. The privilege taxes hereby levied shall be in the same amounts as are levied by the State of Tennessee. The proceeds of the privilege taxes herein levied shall accrue to the County General Fund except where otherwise provided by statute.

Section 2. BE IT FURTHER RESOLVED, that all resolutions of the Quarterly County Court of Weakley County, Tennessee, which are in conflict with this resolution are hereby repealed.

Section 4. BE IT FURTHER RESOLVED, That this resolution take effect from and after its passage, the public welfare requiring it. This resolution shall be spread upon the minutes of the Quarterly County Court.

RESOLUTION MAKING APPROPRIATIONS FOR THE VARIOUS FUNDS, DEPARTMENT, INSTITUTIONS, OFFICES, AND AGENCIES OF WEAKLEY COUNTY, TENNESSEE, FOR THE FISCAL YEAR BEGINNING JULY 1, 1968 AND ENDING JUNE 30, 1969

BE IT RESOLVED by the Quarterly County Court of Weakley County, Tennessee assembled in regular session on the 1 day of July, 1968, that the amounts hereafter set out are hereby appropriated for the purpose of meeting the expenses of the various funds, departments, offices, institutions and agencies of Weakley County, Tennessee, for capital outlay and for meeting the payment of principal and interest on the County's debt maturing during the fiscal year beginning July 1, 1968, and ending June 30, 1969, according to the following schedule:
