WHEREAS, it appears to this court that the county is losing considerable revenue through failure to collect the proper amount of cost on warrants, petitions, and executions.

AND, WHEREAS, it appears to the court that Chapter 410 of the 87th General Assembly set the minimum salary of the sheriff at \$8,950.00.

AND, WHEREAS, it appears to the court at this time that if a greater effort is not made to collect these costs, the sheriff's salary may have to be supplemented from county funds.

THEREFORE, be it resolved by the Weakley County Quarterly Court at its October Term that the clerks of the several courts be requested to make every effort possible to assess sufficient costs, and, if at all possible, including strict proof on a plea of indigency, to collect these costs, to help the sheriff collect sufficient fees to make his minimum salary.

It is the further desire of this court that a copy of this resolution be sent to the clerks of the courts and the president of the bar association.
