

RESOLUTION 1972-11 (continued)

Shall a resolution passed by the Quarterly County Court of Weakley County on April 10, 1972, published in Dresden Enterprise, a newspaper of general circulation in Weakley County, become operative, which resolution levied a tax on the same privileges subject to the "Retailers' Sales Tax Act" under Chapter 30, Title 67, Tennessee Code Annotated, as the same may be amended which are exercised within Weakley County to be levied and collected as provided in said Act and at a rate of three-sevenths (3/7) of the rates levied therein; which provided that the tax shall not exceed \$7.50 on any single article of personal property and excepted from the tax electric power or energy, natural or artificial gas, coal and fuel oil; and which provided for collection by the Department of Revenue of the State of Tennessee?

PRIVATE CHAPTER NO. 216

HOUSE BILL NO. 1535, by Bates, McWhorter

Substituted for: Senate Bill No. 1465 by Hamilton

AN ACT to amend Chapter 224 of the Private Acts of 1933 as amended by Chapter 270 of the Private Acts of 1955 the same being the county school board law of Weakley County.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF TENNESSEE:

SECTION 1. Chapter 224 of the Private Acts of 1933, as amended by Chapter 270 of the Private Acts of 1955 is amended by deleting Section 2 in its entirety and substituting in lieu thereof the following:

SECTION 2. BE IT FURTHER ENACTED, That Weakley County is divided into seven school zones which shall be composed of the following civil districts:

ZONE I: Civil District 3 and the Western half of Civil District 2 divided by the Illinois Central Railroad Company's railroad running through the City of Martin, Tennessee.

ZONE II: The Eastern half of Civil District 2, divided by the Illinois Central Railroad Company's railroad running through the City of Martin, Tennessee, and Civil Districts 17 and 20.

ZONE III: Civil Districts 13, 1,4,25,5,24 and 6

ZONE IV: Civil Districts 10,23,11,12 and 15.

ZONE V: Civil Districts 22,9 and 16.

ZONE VI: Civil Districts 14,18,19 and 8

ZONE VII: Civil District 7.

Such districts hereinabove referred to are those existing at the time of the effective date of this Act.

Jim Alewine shall serve as a member of the school board from Zone No. 1 until the August, 1972 general election. Jesse Wade shall serve as a member of the school board from Zone No. 2 until the August, 1974 general election. Eugene Pentecost shall serve as a member of the school board from Zone No. 3 until the August, 1976 general election. Buford Wray shall serve as a member of the school board from Zone No. 4 until the August, 1972 general election. Jack Porter shall serve as a member of the school board from Zone No. 5 until the August, 1974 general election. Robert Moore shall serve as a member of the school board from Zone No. 6 until the August, 1976 general election. Jimmy Dilday shall serve as a member of the school board until the August, 1972 general election. Upon the expiration of the terms of the members herein above set out the members shall be elected for a term of six (6) years in accordance with Chapter 262 of the Public Acts of 1961."

SECTION 2. This Act shall have no effect unless it is approved by a two-thirds (2/3) vote of the quarterly county court of Weakley County before August 1, 1972. Its approval or non-approval shall be proclaimed by the presiding officer of the quarterly county court and certified by him to the Secretary of State.

SECTION 3. For the purpose of approving or rejecting the provisions of this Act, as provided in Section 2, it shall be effective on becoming a law, the public welfare requiring it. For all other purposes it, shall become effective upon being approved as provided in Section 2.


