A RESOLUTION

This Resolution provides the authorization for capital expenditures, not exceeding \$30,000.00, of Weakley County federal revenue sharing funds by Weakley County, Tennessee, for the repair and/or renovation of the Weakley County Courthouse Building.

WHEREAS, the Weakley County Courthouse Building is a structure of approximately twenty-five years of age and is in a state requiring interior and exterior repairs and/or renovation to preserve and maintain the structure and to prevent further deterioration from inadequate repair and maintenance, and

WHEREAS, the Weakley County Courthouse building and appurtenances thereto is a modern structure and should be preserved and maintained in a stately order. Therefore, repairs, replacements, and/or renovations, interior and exterior should be promptly completed. Repairs, replacements and/or renovation means to include the cleaning, painting, repairing, replacing installation and correction of the interior and exterior, and extends to include the plumbing as well as installation of adequate electrical wiring, or such other mechanical corrections as deemed necessary in the circumstances in order to prepare the entire structure to be totally functional, and

WHEREAS, the Weakley County Judge is hereby authorized and directed to secure public bids for such repair, replacements and/or renovations, and to award a contract to the successful bidder for the proposed repair and/or renovation project, and

WHEREAS, TIME IS OF THE ESSENCE AND THE Weakley County Judge is hereby further directed to proceed with reasonable dispatch in securing bids and the letting of contract (s) for the repairs and/or renovations to be completed by September 30, 1973, if possible, and

WHEREAS, it is the duty and responsibility of the Weakley County Quarterly Court to preserve and maintain the property of the County and is, therefore, obligated to protect, defend and preserve the assets of the County; the public welfare requiring. Any part of this resolution conflict with prior Resolutions of this court are hereby recended. Pursuant to the Rules of Court, this Resolution is sponsored by the following Court Members:
