WHEREAS, Weakley County is now being provided motor ambulance service by Paul Hathcoat dba Emergency Ambulance Service under terms of a contract between the Weakley County Quarterly Court and Emergency Ambulance Service dated the 16th day of February, 1977, and

WHEREAS, the Weakley County Quarterly Court Ambulance Committee has met with Paul Hathcoat dba Emergency Ambulance Service, and, in an effort to minimize the amount of the county supplement for motor ambulance service, recommends to the Weakley County Quarterly Court the following modifications to the present contract:

1. Paragraph 4b of the contract is charged as follows:

Delete the last period of the paragraph and  
ADD: except a flat charge is established as follows:

- a. From Nashville, TN and Memphis, TN .....\$150.00
- b. From Jackson, TN ..... 75.00

2. Paragraph 4c of the contract is changed as follows:

Delete the last period of the paragraph and ADD:  
except a flat charge is established as follows:

- a. To Nashville, TN and Memphis, TN .....\$150.00
- b. To Jackson, TN ..... 75.00

3. Paragraph 13 of the contract is changed as follows:

Change the year 1980 to read 1981.

4. Paragraph 5 of the contract is changed as follows:

- a. Change the figure \$61,000.00 to read \$77,000.00.
- b. Change the date for first payment from April 1, 1977 to read August 1, 1978.
