A Resolution to Amend the 1980-81
General Fund Revenue and Appropriation
Budget.

WHEREAS, certain events have occurred requiring adjustments
in the 1980-81 General Fund Budget; and

WHEREAS, the Weakley County Legislative Body's Property and
Property Maintenance Committee has met and deemed it necessary
that earthquake insurance be purchased to cover the Weakley
County Courthouse; funds for the insurance premium (\$ 577.00)
were not included in the 1980-81 Budget; and

WHEREAS, other expenditures have occurred or are anticipated
since the 1980-81 Budget was adopted.

WHEREAS, the Weakley County Legislative Body's Law Enforcement
Committee has met and recommends to the Weakley County Legislative
Body that an additional expenditure of \$2400.00 be approved which
will allow the county to retain a person to assist in the enforce-
ment of the Wheel Tax Resolution, assist in the enforcement of the
Highway Dept. Road and Bridge weight law and assist in enforcing the
litter law; and

WHEREAS, additional Flood Control Revenue has been received by
Weakley County.

NOW, THEREFORE, BE IT RESOLVED by the Weakley County Legislative
Body in its regular meeting on January 19, 1981, that the 1980-81
General Fund Budget be amended as follows:

A Resolution to amend Resolution 1976-10 (Weakley County Rural Road System) adopted January 1976.
