RESOLUTION AUTHORIZING THE FORMATION OF AN INDUSTRIAL DEVELOPMENT CORPORATION

WHEREAS, three citizens and residents of Weakley County, Tennessee, all being duly qualified electors of and taxpayers in Weakley County, have filed with this body a written application seeking permission to apply for the incorporation of an industrial development board or corporation of Weakley County, Tennessee, pursuant to and in accordance with Tennessee Code Annotated Section 7-53-101 et seq., as amended; and

WHEREAS, after study and due consideration and on recommendation of the Legislative Committee, this body finds and determines it to be wise, expedient, necessary and advisable that such corporation be formed.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Weakley County, Tennessee, meeting in regular session, this the 18th day of April, 1983, that:

SECTION 1. The applicants be and are hereby authorized to proceed to form an industrial development board or corporation for Weakley County, Tennessee.

SECTION 2. The proposed certificate of incorporation which was made a part of the application be and is hereby approved to be used in organizing the corporation.
