## RESOLUTION NO. 1984-28

RESOLUTION AUTHORIZING BUDGET AMENDMENTS TO THE JUVENILE COURT FUND FOR THE FISCAL YEAR ENDING JUNE 30, 1985, TO INCLUDE NEW MONIES FROM A JUVENILE PLACEMENT COORDINATOR GRANT AND TO REALLOCATE A PORTION OF EXISTING FUNDS.

WHEREAS, the General Assembly in 1983 enacted legislation, usually referred to as the Jail Removal Bill, forcing local governments and the states to implement, develope and finance alternative ways of handling status and delinquent offenders. The states have been given to January 1, 1985 to comply;

WHEREAS, in the last fiscal year, the State of Tennessee received federal funding from JJDP, with state and local matches, to help them attain total compliance with the removal bill;

WHEREAS, Weakley County has been granted from these funds monies to employ a Juvenile Placement Coordinator, a part-time position that will be filled by our present Juvenile Secretary, who has served in this capacity for the past nineteen months on monies through Madison County. This grant will increase our budget by \$5,933.25 (\$6,592.50 minus \$659.25, match money at 10%) effective October 1, 1984.

NOW, THEREFORE, BE IT RESOLVED By the Board of County Commissioners of Weakley County, Tennessee, assembled in regular session on this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_ 1984, that:

SECTION 1. The Juvenile Court Fund is hereby amended as follows:
