## RESOLUTION NO. 1986-32

A RESOLUTION MAKING APPROPRIATIONS TO NON-PROFIT CHARITABLE ORGANIZATIONS FOR THE FISCAL YEAR BEGINNING JULY 1, 1986 AND ENDING JUNE 30, 1987.

WHEREAS, Tennessee Code Annotated, Section 5-9-109 allows the County Legislative Body of Weakley County to appropriate funds for the financial aid of any non-profit charitable organizations, and;

WHEREAS, the same regulation requires the County Legislative Body to approve the same appropriation at two (2) consecutive regularly scheduled meetings, and;

WHEREAS, the 1986-87 FY operating budget contains appropriations for the financial aid of non-profit charitable organizations;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County on this 21st day of July, 1986.

- 1. That three thousand one hundred dollars (\$3,100.00) be appropriated for the Weakley County Rescue Squad to benefit the general welfare of the residents of Weakley County.
- 2. That six hundred dollars (\$600.00) be appropriated for the Speech and Hearing Center to benefit the general welfare of the residents of Weakley County.
- 3. That five hundred dollars (\$500.00) be appropriated for the Jackson Council on Alcoholism (JACOA) to benefit the general welfare of the residents of Weakley County.
- 4. That five thousand dollars (\$5,000.00) be appropriated for the Community Development Services to benefit the general welfare of the residents of Weakley County.
- 5. That five thousand dollars (\$5,000.00) be appropriated for the Northwest Tennessee Counseling Center to benefit the general welfare of the residents of Weakley County.
- 6. That twelve thousand dollars (\$12,000.00) be appropriated for the Obion-Forked Deer River Basin Authority to benefit the welfare of the residents of Weakley County.
- 7. That twelve thousand five hundred dollars (\$12,500.00) be appropriated for the Weakley County Chamber of Commerce to benefit the welfare of the residents of Weakley County.
- 8. That five hundred follars (\$500.00) be appropriated for Tourism to benefit the general welfare of the residents of Weakley County
- 9. That eighteen thousand five hundred dollars (\$18,500.00) be appropriated for Weakley County Library to benefit the general welfare of the residents of Weakley County.
- 10. That one thousand eight hundred eighty-eight dollars and four cents (\$1,888.04) be appropriated for Northwest Tennessee Development District to benefit the general welfare of the residents of Weakley County.

- 11. That five thousand dollars (\$5,000.00) be appropriated for CHARIS Group Home to benefit the welfare of the residents of Weakley County.
- 12. That seven hundred fifty dollars (\$750.00) be appropriated for U.T.M. Child Find Services to benefit the general welfare of the residents of Weakley County.
- 13. That two hundred fifty dollars (\$250.00) be appropriated for TAMB of Jackson (Aspell Manor) to benefit the welfare of the residents of Weakley County.
- 14. That two thousand dollars (\$2,000.00) be appropriated for Tennessee Division of Forestry to benefit the general welfare of the residents of Weakley County.
- 15. That two thousand three hundred forty-one dollars (\$2,341.00) be appropriated for Crippled Children Services for the Tennessee Department of Health to benefit the general welfare of the residents of Weakley County/

BE IT FURTHER RESOLVED, that all appropriations enumerated one (1) through fifteen (15) above are made subject to the following conditions:

- 1. That the non-profit charitable organizations to which funds are appropriated shall file with the County Clerk and the the disbursing officials a copy of an annual report of its business affairs and transactions and the proposed use of the county's funds in accordance with rules promulgated by the Comptroller of the Treasury, Chapter 0380-2-7. Such annual report shall be prepared and certified by the chief financial officer of such non-profit organization in accordance with Section 5-932 (c), T.C.A.
- 2. That said funds must only be used by the named non-profit charitable organizations in furtherance of their non-profit charitable purposes benefiting the general welfare of the residents of the county.
- 3. That it is the expressed interest of the County Commission of Weakley County in providing these funds to the above named non-profit charitable organizations to be fully in compliance with Chapter 0390-2-7 of the Rules of the Comptroller of the Treasury, and Section 5-932 of Tennessee Code Annotated and any and all other laws which may apply to county appropriations to non-profit organizations and so this appropriation is made subject tocompliance with any and all of these laws and regulations.

BE IT FURTHER RESOLVED, that this resolution shall take effect from and after its passage and its provisions shall be in force from and after July 1, 1986. This resolution whall be spread upon the minutes of the Board of County Commissioners.
