

RESOLUTION AUTHORIZING A ROAD ADDITION FOR THE WEAKLEY  
COUNTY HIGHWAY DEPARTMENT FOR THE FISCAL YEAR ENDING  
JUNE 30, 1991

WHEREAS, road beginning north of State Route 89, thence, continuing to end of Deer Run Drive, thence, east to a cul de sac known as Buck Street. Also east to another cul de sac known as Doe Cove. The entire length of all areas heretofore mentioned will be .3 mile.

WHEREAS, the Weakley County Board of Highway Commissioners recommends the addition of this road to the Weakley County Rural Road Maintenance System.
