

RESOLUTION NO. 1993-65

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF WEAKLEY COUNTY, TENNESSEE TO AUTHORIZE THE FILING OF AN APPLICATION FOR COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS TO THE TENNESSEE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT

WHEREAS, the Board of County Commissioners of Weakley County, Tennessee have committed themselves to public health and safety as well as community development for the benefit of the citizens they represent; and

WHEREAS, said public officials have determined that construction of a new health department facility is the most pressing need of the county; and

WHEREAS, Weakley County, Tennessee has determined its eligibility to apply for funding according to the guidelines for the Community Development Block Grant Program;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Weakley County, Tennessee, meeting on this the 18th day of October, 1993, that application be made to the Tennessee Department of Economic and Community Development for Community Development Block Grant funds in an amount not to exceed \$300,000, with required local match funds in the amount of \$48,837 and additional local funds in the amount of \$222,913 to be provided by Weakley County, to constitute a total project cost of \$571,750.

BE IT ALSO RESOLVED that the County Executive is authorized to make and sign application for said funds, authorize any required environmental documentation, and enter into any and all necessary agreements and assurances to consummate the application and implement the project.
